DUST CONTROL SECTIONS WILL BE BLADED THROUGH STARTING NOV. 15TH AND MAY BE BLADED THROUGH AT ANY TIME IF THE CONDITION OF THE ROAD IMPEDES TRAFFIC. PRESERVE YOUR DUST CONTROL BY KEEPING IT PROPERLY MARKED AND BY FILLING POTHoles WITH ROCK. POWESHIEK COUNTY'S DUST CONTROL POLICY CAN BE FOUND AT www.powehiekcounty.org.”
