“POWESHIEK COUNTY ALLOWS THE PLACEMENT OF DUST CONTROL ON ROCK ROADS. THE INTEREST OF MOTORIST TO HAVE A WELL-MAINTAINED ROAD TAKES PRIORITY OVER THE INTEREST TO SUPPRESS DUST. DUST CONTROL SECTIONS WILL BE BLADED THROUGH STARTING OCT. 15TH AND MAY BE BLADED THROUGH AT ANY TIME IF THE CONDITION OF THE ROAD IMPEDES TRAFFIC. PRESERVE YOUR DUST CONTROL BY KEEPING IT PROPERLY MARKED AND BY FILLING POTHoles WITH ROCK. POWESHIEK COUNTY'S DUST CONTROL POLICY CAN BE FOUND AT www.powehiekcounty.org.”
