PLEASE HAVE AREA TO BE TREATED MARKED WITH COUNTY ISSUED STAKES AT EACH END ON TRAFFIC SIDE OF ROAD. APPROXIMATELY 6' FROM THE EDGE OF THE ROAD WITH A CLEARED AREA MAINTAINED AROUND THE STAKE. STAKES ARE AVAILABLE AT THE COUNTY SHOP AT 1200 HWY 2 WEST, CENTERVILLE, IA. STAKES NEED TO BE IN PLACE FOR THE ENTIRE SEASON. EXPLAIN ON APPLICATION FORM WHERE TREATMENT IS TO BE PLACED. APPANOOSE COUNTY STAKES ARE MANDATORY, ANY OTHER STAKES WILL NOT BE ACCEPTABLE.

**PLEASE NOTE: ALL SPOTS WILL BE MEASURED. ANY DISTANCE STAKED OVER AMOUNT ORDERED WILL BE BILLED TO CUSTOMER. IF YOU ARE NOT SURE OF STAKE DISTANCE AND DO NOT WANT MORE THAN ORDERED PLEASE WRITE IT ON THE APPLICATION.**

FAILURE TO MAINTAIN VISABLE COUNTY STAKES THROUGHOUT THE ENTIRE SEASON, MAY RESULT IN LOSS OF DUST CONTROL, WITHOUT LIABILITY FOR THE COST OF ANY NEW DUST CONTROL APPLICATION.**
